#### Income

is derived from dividends in shares in COIF Charity Investment Fund and income from agricultural allotments. This is partly from rents and partly from contracted farming operations. Current contractor is Mr. Angus Hamilton.

### Distribution

is made each Christmas to people who have lived in the parish for at least six months. It is made on the basis of one share to each household with one or two persons who are of State pension age. Shares are based on the annual surplus of income over expenses. In 2018 34 households received shares.

As the Trust has an ecclesiastical element, five shares are given to the Earl Stonham with Stonham Parva Parochial Church Council as a contribution to the priest's expenses in this village.

The Trust will also consider grants to younger people for educational purposes, to a maximum of one share.
