<u>22.205.3 Footpaths/Pavements</u> – Report made to Highways about the overhanging branches along the pavement between The Magpie to Chapel and this has been deemed as acceptable and not in need of cutting back.

Footbridge repair (mid-point on Church Lane leading to allotments) to be chased up as this has not been fixed still.

Budget discussion took place, all happy with the budget except an increase to playing field/hedging cuts to $\pounds 1600$ as it was felt that the Parish Council may have to start using contractors to cut hedging within the village if SCC or owners do not do this.
